

# 2022 Written Examination – High School Division

### **General Instructions**

This examination consists of short-answer questions (part 1) and a long essay question (part 2). Varsity students, you must write SIX of the eight prompts in part 1 and ONE of the two prompts in part 2. Junior Varsity students, you must write FIVE of the eight prompts in part 1 and ONE of the two prompts in part 2. You may use this packet for planning and prewriting, but please make certain to write all of your responses in the appropriate place on the answer document.

### **Part 1 Instructions**

You will choose and answer the specified number of questions from part 1. Write your answers in the space provided on the answer document and circle the number of the question you are answering in the appropriate place. In part 1, appropriate responses to each part should be roughly one to two sentences. Please write only in the space provided for each question – do not write outside of the boxes or write multiple sentences on each line.

### Question 1

Answer A, B and C with reference to the Roman Republic or Empire during the time period from roughly 300 BCE to 300 CE.

- A. Identify and briefly explain ONE specific engineering or military contribution of ancient Rome to the classical world.
- B. Identify and briefly explain ONE specific political contribution of ancient Rome to the classical world.
- C. Identify and briefly explain ONE specific artistic or intellectual contribution of ancient Rome to the classical world.

### Question 2

Answer A, B, and C.

- A. Explain ONE way the spread of religion led to intensification of trade in Africa between 600 and 1200 CE.
- B. Explain ONE effect of the intensification of trade in Africa between 600 and 1200 CE.
- C. Explain ONE way the inclusion of Africa in trade networks affected neighboring regions between 600 and 1200 CE.

### **Question 3**

Using the following source, answer A, B, and C.

Source: Conrad of Negenberg, German philosopher and theologian educated at the University of Paris, Concerning the Mortality in Germany, book written in Latin, 1350.

"It does not seem to me that the Jewish people can be the cause of this general epidemic throughout the whole world, as many suggest. My reasoning is as follows.

First, it is well-known that in most places where the Jewish people dwelled, they died in droves from the exact same disease as the Christians. If they really caused the epidemic, they would not have killed themselves and others of their faith.

Second, many people say that the Jews poisoned the wells, causing the disease. This also seems doubtful, because after the wells full of polluted water had been purified, the people still died in great numbers. Further, in cities that use water only from great rivers like the Danube, the inhabitants have also died in large numbers.

Moreover, even after all the Jews in many places had been killed and were completely driven out for nearly two years prior, the disease now strikes these same places just as powerfully as before."

A. Describe the historical contextualization in which the author wrote his book.

B. Explain ONE way in which the disease referred to in the passage influenced the development of urban areas in the period 1200-1450.


C. Explain ONE way in which the point of view the author is arguing against led to conflict in later periods.

C. Explain ONE similarity or ONE difference in the way that land-based and maritime empires approached the ethnic diversity of their populations in the period 1450-1750.

B. Identify and briefly explain how the cause you chose for A is similar to the main cause for one of the two remaining conflicts.C. Identify and briefly explain one major difference between the causes for the two conflicts you chose.
